Under PMUY, beneficiaries receive a deposit-free LPG connection that covers the security deposit of cylinder, pressure regulator, suraksha hose, Domestic Gas Consumer Card (DGCC) booklet, and installation charges. In addition, the first refill and stove are also provided free of cost. Beneficiaries are not required to make any payment for these benefits.

('Households' having Piped Natural Gas connection are not entitled for subsidized LPG).
e)	That I or any of my Household members (as per my family composition) do not have any existing LPG connection.
f)	That as and when second cylinder is issued to me against this connection the same will also be used in the same kitchen and with the original connection.
g)	That I will also keep the PMUY Equipment (LPG Cylinder, Pressure Regulator, Stove) in my registered address, failing which my entitlement/services will not be valid.
h)	That I shall not hold IOC/HPC/BPC/MoP&NG responsible for any delays/non receipt of subsidy in case of change/closure / deactivation of my Bank Account/ Bank not in NACH or for any rejection by Bank.
i)	That In case of any revision/change in the above information (Registered Address/Mobile Number/Bank account details/Family member details/Ration card or family composition document details), I will inform the LPG distributor/OMC.
j)	That I am aware and authorize Oil Marketing Company(OMC)/bank to update/share my and my family member Aadhaar No./demographic data/bank account details/Ration card details or family compositon document details and other details as collected in this KYC form between themselves for de-duplication/authentication/verification purposes.
k)	That I have understood and filled in the Deprivation Declaration form and give my consent for verification (including physical verification) of the particulars mentioned therein.
